Since 1996, KABOOM! has collaborated with partners to build, open or improve more than 17,000+ playgrounds across the country in their quest to end playspace inequity. Depending on your community’s needs, available space on your property, and available funding, KABOOM! offers three different types of playspaces. Opportunities for Community-Built Playspace grants are specific to certain cities or metropolitan areas within the U.S. KABOOM! is currently seeking applicants in the list of cities and metropolitan areas on their website. If your community isn’t within one of the communities listed, they do not recommend applying at this time. The Land and Water Conservation Fund (LWCF) supports close to home recreation opportunities and provides community access to the outdoors. It’s likely that one of your favorite state or local parks has received support from LWCF. Since its inception in 1965, LWCF has helped fund over 46,000 projects in communities and neighborhoods across the country. They provide matching funds to state and local governments. The first step for potential applicants is to contact the appropriate State office to find out about local application deadlines, state priorities and selection criteria, and what kinds of documentation are required to justify a grant award.

Award Amount: Varies

Lowe's is investing \$100 million in a 5-year program to restore and revitalize community spaces across the country through the Lowe's Hometowns program. Each year through 2026 Lowe's selects 100 large-scale community projects, chosen from consumer nominations, to be completed in partnership with local nonprofits, Lowe's store associates and community volunteers. Additionally, nearly 1,700 additional projects are selected and completed by Lowe's stores, supply chain and store support centers across the country. Lowe's Hometowns restores and revitalizes spaces that serve as hubs and heartbeats of communities including food pantries, parks, community centers, gardens, safe and affordable housing, first responder facilities and programs serving veterans. The 100 projects selected in 2025 spanned 44 states and Washington, D.C. Follow along on social media for project updates using #HowLoweHelps.



Columbia Bank is an award-winning regional bank serving the western United States. They maintain more than 350 locations across Arizona, California, Colorado, Idaho, Nevada, Oregon, Utah, and Washington. In 2025, it completed its purchase and rebranding of Umpqua Bank, taking over Umpqua's Community Grants program. It is unclear what the new grantmaking process will be. Grantseekers should keep checking the website for 2026 funding announcements.

The Daniels Fund supports highly effective nonprofit organizations working to improve lives and strengthen communities in Colorado, New Mexico, Utah, and Wyoming. The Daniels Fund's main priorities are helping people with disabilities, early childhood education, homelessness, K-12 education reform, drug and alcohol addiction, amateur sports, youth development, and aging. The Daniels Fund accepts grant applications by invitation only. If you are interested in applying, complete the Grants Eligibility Quiz online to determine if you should proceed with a grant inquiry. Their funding is highly competitive, with only the top organizations in their field selected.

**Philip L. Graham Fund** (DC, MD, and VA)

The Fund awards grants across a geographically vast area that includes 10 counties in Virginia and Maryland as well as the District of Columbia. Grantees include large, regional organizations as well as small, community-based groups. Their areas of focus are health & human services, education, arts & humanities, and community endeavors. The Community Endeavor grants have supported a broad spectrum of organizations, such as institutions of national significance located in the metropolitan area as well as the improvement of local parks and playgrounds.

This foundation's mission is to establish meaningful partnerships and amplify impact to build inclusive communities across M&T Bank's footprint. 501C3 organizations must operate or serve individuals within the cities/towns where M&T Bank conducts business. Does not fund (among others) booster clubs, PTA's, public schools, municipalities, athletics or sports teams. Applications should be submitted at least 8 weeks before a decision is needed.

The Meyer Foundation supports organizations that are building power to achieve a racially and economically just Greater Washington. First step is to submit an Interest Form available on their website, and within 30 days they will let you know if they want to receive a full application from you. The Foundation defines the Greater Washington Region to include Washington DC, Montgomery and/or Prince George's counties in Maryland, Arlington, Fairfax and/or Prince William counties and/or the cities of Alexandria, Fairfax, Falls Church, Manassas, and/ or Manassas Park in VA.

The Foundation does not fund new programs. They instead focus on proven programs. They are primarily focused on programs that help end childhood hunger, address children's mental health and those that support community development in the Montpelier, VT and Dallas, TX areas. The vast majority of their funding is centered on central and northern VT and the Dallas, TX area where their employees live and work. Decisions on grant awards will usually be made within 3 months after the March 31 deadline.

The Edwin S. Webster Foundation is dedicated to supporting 501(c)(3) organizations in the New England area with capital programs, special projects, and operating income. Areas of focus include hospitals, medical research, education, youth agencies, cultural activities, and minority enrichment programs. The Foundation prefers to work with organizations in their community that are well known to them, so don't expect to earn a grant without developing a prior relationship. The best way to secure funding is to gain strong support from a member of the board of trustees. Proposals must be submitted through the Foundation's online grant system.

Priorities include fighting hunger and homelessness, disaster relief, expanding STEM education, building life skills, improving health and wellness, and promoting arts and culture.

Amex allows small businesses to get creative in creating or improving a community-centric space within the business such as a patio, performance stage, or area used for community gatherings. Most recent application period opened Nov 29, 2025 and closed on Jan 23, 2026. Funding includes 500 grants of \$20,000 each.

Amex also sponsors grant programs for their employees. Employees can access details on the company intranet.

- Serve2Gether - Once an employee accumulates 25 hrs of volunteer service to a nonprofit, they can request a grant from American Express.
- Give2Gether - Eligible charitable contributions are matched up to \$8,000 per year.

The Foundation provides funding to organizations globally that provide programs and services in the following focus areas: Education, Arts & Culture, Civic Engagement, Environment and Girls Empowerment. Applications may be submitted through the Foundation's online application portal on their website. Deadlines for applications are January 15th and June 15th every year and proposals are reviewed twice a year in their Board meetings. Applicants will receive a response from between March 15-31 or August 15-31, depending upon when the request is received. In general, projects that include opportunities for employee engagement and stimulate innovation are given priority.

BOA's charitable foundation focuses its 2026 philanthropic efforts on advancing economic mobility, specifically through grants for basic human needs, income creation (workforce development), and community revitalization. Nonprofits must demonstrate alignment with these priorities to receive funding. Organizations must be 501(c)(3) nonprofits and operate within designated Bank of America markets. Decisions for some 2026 cycles are scheduled to be announced early in the year. It is highly recommended to check the official Bank of America Making an Impact website regularly for the most up-to-date 2026 RFP releases and deadlines.

The Bayer Fund's focus is to provide support in two areas: food and nutrition, and health and wellness. They concentrate their efforts where a majority of their employees live and work: St. Louis, MO and Northern New Jersey. They also offer grants in smaller Bayer communities (see website for list). Applications are accepted by invitation only, and applicants must be located within about 55 miles of an eligible Bayer site community. If you don't know the contact at your local site, you may submit a summary of your project on Bayer's website. The site contact will respond with information on your eligibility to apply if there is interest.

The Ben and Jerry's Foundation is a social justice organization. Their National Grassroots Organizing Program (NGO) offers unrestricted, general operating support grants of up to \$30,000, with an average grant size of \$20,000, to small (budgets under \$350,000), constituent-led grassroots organizations

throughout the United States and its territories. You must demonstrate how your project is linked to grassroots social change. Start the process by taking their eligibility questionnaire online. This foundation no longer offers a rolling, year-round application process.

The main areas of focus are economic development, education, community development and health. Funding focus by region are: West Virginia – economic development, education, community development, health. Southwestern Pennsylvania – Economic development, education. First time applicants or those unsure of whether their project is in line with the Foundation's priorities should call or send an email to the Foundation.

Black Hills Energy's Charitable Giving Program awards contributions or sponsorships to eligible applicants that are 501(c)(3) organizations (recognized as tax-exempt by the IRS) and schools or school districts. Organizations within or serving residents in their service territory need to apply six months prior to an event. Please allow up to 120 days to receive a decision. Their key priorities are thriving communities, conservation and future leaders. Applications are accepted year-round through the foundation's website.

The Foundation is dedicated to supporting the communities they serve and where their employees live, work, and volunteer. Applicant organizations should exist in or serve a community near one of BNSF's rail lines to be considered for grants. Please refer to the BNSF system map included in the Policies section to determine whether you are located on a BNSF route. Preference is given to requests associated with civic, STEM education and youth services. For complicated grant requests, it could take up to one year for a final decision to be made.

Since 1953, The Campbell's Foundation has supported local communities through direct grants, employee matching gifts, and partnerships with local, regional, and national nonprofits that build healthy communities in their hometowns. Their three main focus areas: increasing food access, encouraging healthy living, and nurturing neighborhoods in communities where Campbell employees live and work. Each year employees from each Campbell location nominate local nonprofits in their community to apply. Check the website to see if you are in a Campbell community.

The great majority of grants are given to organizations located in, and for projects to be conducted within, the state of Iowa and portions of Illinois, as well as to other organizations in which Mr. Carver had an interest during his lifetime. The Carver Trust supports biomedical and scientific research, scholarships, and programs addressing the educational and recreational needs of youth. Projects receiving Trust funding under the youth program designation are typically designed to complement curriculum-based education and encourage individual development and physical well-being. Of the grants awarded within this category, a significant portion has been directed toward the efforts of organizations advocating for disadvantaged and disabled youth and their families. In addition, grants to help communities establish safe and affordable recreation opportunities are also part of the youth-directed programming. The Trust offers strategic funding for the development of public recreation facilities and related activities for children, with priority given to projects in the Iowa counties of Muscatine, Cedar, Louisa and Scott, as well as Rock Island and Mercer Counties in Illinois. There is a photo on their website of a playground that, presumably, was funded by the Trust.

Award Amount: Varies. New applicants won't receive more than \$5,000.

The Cathay Bank Foundation does not accept unsolicited grant apps. Your nonprofit must be invited to submit a Letter of Interest by Cathay Bank or a Foundation officer. If the Foundation is interested in your LOI project, they will ask you to submit a full application. Their focus is on helping nonprofits serving a majority of low to moderate-income people and/or communities in these areas: community & economic development, education, health & welfare. Nonprofits must serve or be located in the communities that Cathay Bank serves.

In 2026, Centene Foundation will begin an invitation-only model for grant applications. The core of the foundation is helping health-related organizations and causes. Centene will also consider projects or programs aligning with one or more of Centene Corporation's focus areas: Healthcare (Including Social Determinants of Health), Social Services and Education. Organizations interested in applying for a Centene Foundation grant are encouraged to reach out to their local Centene health plan.

The Chisholm Foundation aims to fund nonprofit organizations that align with its vision of supporting education, the arts, and religion, and welcomes applications from anywhere in the U.S. The Foundation awards grants twice a year, in May and November. The Foundation is interested in new or demonstration projects that can be continued and expanded with the help of additional financial supporters. They encourage applicants to seek matching gifts or challenge grants to magnify Foundation funds.

## **Christopher and Dana Reeve Foundation – Quality of Life Grant**

Award Amount: \$5,000-\$24,999

The Christopher and Dana Reeve Foundation focus their efforts on programs that positively affect individuals and families living with paralysis. Their Tier 1 (Direct Effect) grants are open-focused to support a wide range of projects and activities. Funded projects are expected to be completed within 12 months of award. The Reeve Foundation gives special consideration to organizations that serve returning wounded military and their families, and to those that provide targeted services to cultural communities. This includes (but not limited to): persons at risk of incarceration, current or released prisoners; non-majority groups; homeless; tribal communities; limited English proficiency; rural residents; migrant workers; low-income and/or poverty populations; and newly injured people with paralysis and their caregivers. Fiscal sponsors are not allowed to apply on behalf of non-501C3 organizations. Examples of funded projects include accessible playgrounds/ball fields and accessible community spaces.

The Coca-Cola Foundation is a highly competitive funder because it offers grants in the U.S. and globally. In the U.S. they often prioritize their “hometown” of Atlanta, GA. They don’t accept unsolicited proposals for grants. The foundation wants to invest in transformative ideas and institutions. Their focus areas aim to address sustainable access to safe water, watershed conservation, recycling value chains, disaster preparedness and response, economic prosperity and causes impacting Atlanta.

CSX awards grants to eligible non-profit organizations that make a strong, quantifiable impact on their greater communities. The online grant application is open 12 months a year. Applicants are encouraged to apply early and with one funding request. Every effort is made to respond to applications within 30–45 days. Check the website – this grant is available in 27 states and the District of Columbia.

Submit proposals at least 90 days before you want a response. The board considers grant proposals in January, March, May, July, September, and November.

The Dr. Scholl Foundation grants funding nationwide in the areas of education, social services, healthcare, civic and culture, and environmental. Applicant organizations can submit a Letter of Interest at any time after Oct 1 until Jan 31 of the next year. If an organization receives an invitation to submit a full grant application, the grant is due on March 1.

The Duke Endowment's work in North Carolina and South Carolina focuses primarily on four program areas: child and family well-being, health care, higher education, and rural church. For the Child and Family Well-Being grants, a pre-application process will determine the eligibility of an organization. Within 30 days of submitting the pre-application form, organizations will receive a Request for Proposal or a notice that your project does not align with Duke Endowment's current priorities.

The applicant must be registered with the Secretary of State as a 501(c)3, have a local board, and attend a mandatory workshop to apply by June 30.
